## LEGISLATIVE: ENACTED

2174, Missing Persons And Unidentified Remains Act Of 2019

- Passed in December 2020, signed into law by the President on December 31<sup>st</sup>,
  2020
- Expands the eligibility to apply for grants and authorizes use of grants to pay for the costs incurred by grant applicants
- Establishes and expands programs developed to improve reporting of unidentified persons; allows for funding to be used to hire and maintain additional DNA case analysts and technicians, fingerprint examiners, and forensic odontologists and anthropologists needed to support identification programs

## LEGISLATIVE: ENACTED

S.1130 Scarlett's Sunshine Act

 Signed into law on December 31<sup>st</sup>, 2020
 Will authorize Secretary of HHS to continue support for Sudden Unexplained Infant Death and Sudden Death in the Young Case Registry at the CDC
 Will also provide grants to improve investigation

## LEGISLATIVE: ENACTED

#### H. Res. 572/S. Res. 320, Forensic Science Week

- Passed Senate and Introduced in House
- Several members of Congress published press releases in support of forensic science and ME's/Coroners

S. 3201, Temporary Reauthorization and Study of the Emergency Scheduling of Fentanyl Analogues Act

- Passed February 6, 2020, after a hearing
- Bill provides temporary reauthorization until May 6, 2021
- Includes a study and report on the impact of class wide scheduling-due Feb 2021

## LEGISLATIVE: NOT ENACTED H.R. 8239/ S. 4568 Forensic Science Research and Standards Act of 2020

- New negotiations began in early 2019 and agreement was reached
  Codification of OSAC and creation of federal research agenda & grants for Standard Development Organizations such as ASB
   Other interest groups protested provisions of the bill, thus preventing passage
- New negotiations will begin again with new Congress

## **NON-LEGISLATIVE ITEMS**

Medico-Legal Death Investigation-Data-Working Group

- A CDC/NIJ collaborative group was formed in 2020 called the MDI-Data-WG which includes many CFSO association members
- Looking at ME/C data to determine collection and sharing of data
- Group is tasked with multi-year project of developing recommendations for federal government

## NON-LEGISLATIVE ITEMS

#### **Testimony to LE Commission**

- CFSO Chair testified in front of DOJ LE Commission regarding how labs and LE can work more collaboratively on domestic abuse and sexual assault investigations

**ABA Fordham Meeting** 

- Meeting called off due to COVID
- CFSO continues to engage ABA to initiate constructive dialogue

NIJ/BJA Solicitations

- CFSO worked with OJP and BJA to address critical issues concerning grants

- Work to restore 2019 CEBR funding to three laboratories

## NON-LEGISLATIVE ITEMS

NIJ Needs Assessment - CFSO played key role in publishing of document in 2019 and raised awareness of importance of document

Federal Forensic Science Census Work - CFSO worked to increase response rate on census

Briefing of Biden Transition Team on Forensic Science Priorities - Provided written briefing materials for new AG

- Began discussions with Hill staff in 2020 about technical edits
- Expected to be priority in this Congress

- Expected to be introduced early this year
