URGENT AND IMMEDIATE ACTION REQUIRED ON COVERDELL FUNDING

We have been working on the reauthorization of the Justice for All Act for several years. This bill is in draft form and will be introduced any day. We are working on the final negotiations on your behalf. The Coverdell forensic science grants are a portion of this Justice for All Re-Authorization Act of 2022. In working on the reauthorization of this bill, the CFSO has asked for an increased authorization to \$50M a year. We have received \$35M a year for the past several years, and this would authorize an increase of \$15M a year. It has come to our attention that many Members of the Senate and House, specifically on the Judiciary Committee have opposed the increase due to fiscal matters. The CFSO is asking for your help.

Please call your Senators and Members of Congress on the Judiciary Committee (see attached list) and ask to speak to the staff that handles issues for the Judiciary Committee. Ask them to support the increased authorization to \$50M in the Justice for All Act Re-authorization for the Coverdell grants. Reference the below national statistics and <u>please</u> provide specifics about how you use the funding and issues in your state that require you to need more funding. Please provide your lab specific data to your Senators and Representatives. For Medical Examiner and Coroner Offices, please reference that this is the only DOJ funding you have for operations. NON-DNA DATA (except Firearms):

FORESIGHT, an organization funded by NIJ, compiles data directly from the crime laboratory functional areas to help laboratories improve efficiencies and resource allocations. Below is data compiled in 2020 for all disciplines other than firearms and DNA. Firearms data was compiled by the American Society of Crime Lab Directors. Of note during this timeframe, federal funding has not increased nor has state funding.

FIREARMS EXAMPLES:

The American Society compiled a snapshot of firearms cases. There is a dramatic increase in many states of submitted firearms cases thus causing a significant backlog. This is made worse by a decrease in trained firearms due to loss of firearms training courses at ATF (capacity exists to train only 12 firearm examiners a year) and the lack of individuals seeking to be firearms examiners.
